INTRODUCTORY NOTE

Maharashtra Film, Stage and Cultural Development Corporation Limited is registered under the companies Act, 1956 in the year 26th September, 1977 having registered office at Dadasaheb Phalke Chitranagri, Film City, Goregaon (East), Mumbai 400 065 herein referred as “The Corporation”.

The Corporation is engaged in providing infrastructure for Entertainment Industry. It is spread in the area of 521 acres of land. It has 8 shooting floor (studios) of various sizes ranging from 2000 sq. ft. to 14000 sq.ft. And height of 30 ft. and more than 74 outdoor shooting locations and other allied facilities for the shooting of Film, Television Serials, Advertisement etc.

SCOPE OF WORK

The Corporation provides **outdoor and indoor** shooting facilities to film and television producers. During shooting in its **8 studios**, it is essential to provide basic infrastructure like Tarafa, background, electricity and air condition facility etc. to producers. Therefore, Tarafa is one of the essential facilities to be provided by the studio owner. Tarafa is used for fixing lights on the set and the potential of business depends on proper arrangement of these facilities.

At present Corporation does not have arrangement of assembling, dismantling Tarafa and no means to procure material for Tarafa. Therefore, this arrangement is to be done on behalf of the Corporation by appointing an experienced contractor / Catwalk arranger. The Catwalk / Tarafa arranger will have to provide these facilities through his experienced staff in a hassle-free manner to the producer as per requirement all the time during the contract period.

The tenderer should manage to fix and dismantle Tarafa / Catwalk in all 10 Studios and its outdoor location on behalf of the Corporation and also should make available wooden planks of various size, Dimara (wood), Dori (rassi) nails and other material as per following Terms and Conditions:

1. Tenderer should be connected with Film Industry from last 10 years. He will have to submit documents evidence for the same. Please attach self-attested Copy.
2. The tenderer should have minimum 10 years of experience in the field of assembling and dismantling of Tarafa (wooden planks) and other materials in studios used for shooting purposes.
3. The tenderer shall be required to keep ready stock of planks of various sizes and material like Dimra, Dori, Patti, nails etc. required for various studios of the corporation.
4. The tenderer should keep enough skilled labourers ready for all shifts for tarafa.
5. The labourers should be experienced & skilled in Tarafa work and should have registration / Identity Card.
6. The quality of wooden planks, Dimra, Dori as well as other material should be such as to avoid any untoward incident / accident during the shooting period. **If any accident or any untoward incident takes place during shooting, because of supply of inferior quality material, unskilled workmanship or not provision of the required safety equipment for assembly, dismantling or transporting the material to and fro, the entire responsibility shall lie on the tenderer and he will responsible to compensate the damages sustained by any party to labour. The corporation will not be held responsible for anything.**
7. The tenderer should have arranged all the welfare measures for the labourers engaged by him and keep ready in the corporation premises at his own cost (as required by various legislation or under various rules in that behalf) of ESIC, Labour registration.
8. The successful tenderer shall have to take out comprehensive insurance policy for labour engaged by him, as per law and take out all risk policy for safety of the man and material etc.
9. The producer, who has booked the studio and outdoor location, shall place the orders for tarafa **arrangement** directly to **studio department** of the **corporation by filing** the permit / challan.

10. The **tenderer should personally** visit various **Studios / Outdoor Locations** located in the **Film City** and **take measurements** and see the **Studios / Outdoor Locations** for **themselves and then quote percentage of share to the corporation and for himself for all the Studios / Outdoor Locations.**
11. No **complaint in respect** of actual **measurements not confirming to those given** in the **list attached herewith shall be entertained.**
12. The **tenderer should quote separately percentage of share to be given to the corporation and for himself for the following**
 - a) **Assembling & Dismantling Tarafa.**
 - b) **Providing wooden planks of required sizes for tarafa.**
 - c) **Materials for fixing Dimra, Dori, Patti, nails etc.**

However, the rate for assembling and dismantling tarafa, wooden planks and **materials should not exceed the limit set out by the corporation.**
13. The **tenderer will have to take care that corporation does not receive any Complaint in this regard from various producers during the shooting period. If at all any producer complaint about providing wooden planks and other materials or fixing / dismantling the same the tenderer will be solely responsible, and action will be taken against him.**
14. The **tenderer shall be solely and fully responsible for the safety of his material kept in the premises of the corporation. If space is available, he may be provided with godown for the storage of material on monthly rent decided by the Corporation.**
15. The **tenderer shall have to enter into a separate contract for this purpose. However, providing godown will be at the discretion of the corporation and only if the same is available. Therefore, the tenderer cannot insist upon providing such godown by the Corporation.**
16. In case if godown / space is allotted to the successful tenderer, he has to pay necessary water charges, electricity bills, and maintain rules and regulations of the corporation.
17. The **successful tenderer will raise invoice to the corporation at the end of the month equal to his share amount along with applicable taxes from time to time and the corporation will pay his share after deducting all applicable taxes as per Government Rules and Regulation.**
18. The **tenderer will have to attach tax clearance certificate / return file acknowledgement for last 5 years and certificate to the effect that GST has been paid fully for the last 2 years to the GST Department.**

19. No conditional offer shall be accepted in any circumstances. Hence, liable to be rejected.

26. No Charges such as transportation and loading, unloading charges will be given by the production houses to the successful bidder for Tarafa Making / Dismantling.

PAYMENT TERMS

1. The payment of the successful tenderer shall be based on percentage of share quoted by him as given in the Financial Bid.
2. The Successful tenderer will raise invoice to the corporation at the end of the month equal to his share amount along with applicable Taxes from time to time and the corporation will pay his share after deducting all applicable taxes as per Government Rules and regulations.
